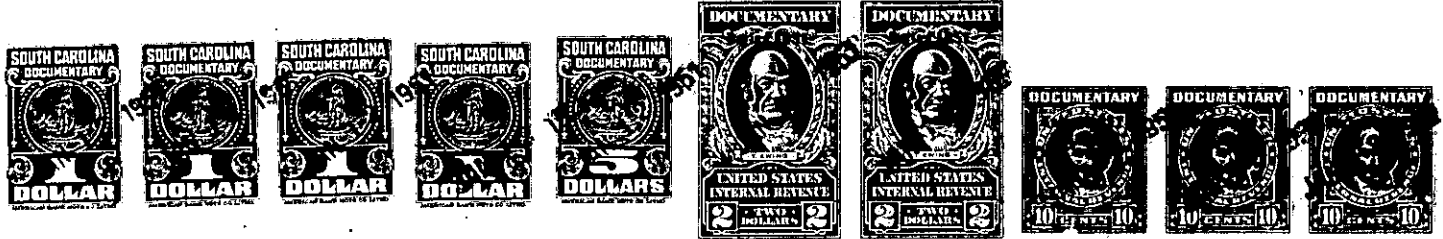


Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Marshall McCauley and Noette McCauley,

all that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina on the Northeast side of Hill Top Drive and the South side of of Forrest Drive, near Travelers Rest, being known and designated as Lot No. 37 as shown on plat of a subdivision for Ray E. McAlister, made by Pickell and Pickell, Engineers, dated October 16, 1948 and recorded in the R. M. C. Office for Greenville County in Plat Book J. Page 153, and having the following metes and bounds,
TO WIT:

Lot No. 37: BEGINNING at an iron pin on the Northeast side of Hill Top Drive at joint front corner of Lots 36 and 37 and running thence along said northeast side of Hill Top Drive N. 42-50 W. 100 feet to an iron at corner of Lot No. 38; thence along line of said Lot No. 38 N. 23-08 E. 200 feet to an iron pin in line of Lot No. 39; thence along line of said Lot 39 S. 42-50 E. 100 feet to an iron pin at rear corner of Lot 36; thence along line of said Lot 36 S. 23-08 W. 200 feet to the beginning corner. This is part of the land conveyed to the grantor by G. P. Peterson by deed dated September 22, 1945, recorded in the R. M. C. Office for Greenville County in Deed Book 270, Page 14.
