

in the State aforesaid, That I, L. E. Girardeau in consideration of the sum of Twenty-eight Hundred and No/100 (\$2800.00) - - - _ DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mrs. Mary Thomas, her heirs and assigns, forever:

All that piece, parcel or lot of land in the City of Greenville, Greenville Township, Greenville County, State of South Carolina, and on the Northwestern side of Jones Street, being described by metes and bounds as follows, to-wit:

BEGINNING at a point on said Jones Street, 217.5 feet more or less from the South line of West Washington Street, said place of beginning being the Southeast corner of the lot of land owned by Greenville Ice Cream Company, and running thence in a Northwesterly direction along the Southern line of said lot 129 feet to an iron pin on the line of the lot sold by Lois Hudson Leathers to Greenville City Schools; thence in a Southwesterly direction along the line of the School lot 50 feet to an iron pin at the corner of the lot formerly owned by Mrs. Emma G. Goodlett; thence along the line of the Goodlett lot in a Southeasterly direction 129 feet to an iron pin on the Northwestern line of Jones Street; thence along said line of Jones Street in a Northeasterly direction 50 feet to the place of beginning.
