All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot #2 according to plat of property of the grantor by Dalton & Neves, Engineers, November, 1950, the same being a portion of tract #13 as shown on plat recorded in the R. M. . Office for Greenville County, S. C. in Plat Book "R", Page 65, and Lot #2 being more particularly described according to survey and plat by Pickell & Pickell, Engineers, January 9, 1951, as follows:
