That I, Bertha Sprouse Knighton, in the State aforesaid, in consideration of the sum of Eleven Hundred Fifty and 00/100 (\$1150.00)-----DOLLARS, and assumption of mortgages hereinbelow referred to, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mary Lou L. Scott, her heirs and assigns, forever:

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Southeast side of Alaska Avenue (formerly known as Morningside Drive) in the City of Greenville, County of Greenville, State of South Carolina, being known as Lot 6 on plat of Parkview, made by Dalton & Neves Engineers, June 1942, located in the R.M.C. Office for Greenville County, S.C., in Plat Book "M", at page 49, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Alaska Avenue, at joint front corner of Lots 6 and 7, said pin being 225 feet in a Northeasterly direction from Neely Drive, and running thence along Alaska Avenue, N 53-43 E 50 feet to an iron pin at corner of Lot 5; thence with the line of Lot 5, S 36-17 E 150 feet to iron pin thence S 53-43 W 50 ft. to a point; thence along the line of Lot 7, N 36-17 W 150 feet to an iron pin on the Southeast side of Alaska Avenue, the beginning corner.

The Grantee to pay 1951 taxes.
