Todd by W.J. Riddle, Surveyor, dated February, 1920 as follows:

BEGINNING at a stake 3X in the center of Gilder Creek running thence S. 66-W 6.77 chs. to a stake 3X; thence S. 3-30 W. 2.26 chains to a stone 3X; thence S. 53-30 E. 28.00 chs. to a stone 3X in the center of a county road; thence along the center of said road as the line N. 51-15 E. 15.30 chs. to a stone 3X; thence leaving said road N. 43-1/4 E. 5.00 chs. to a point; thence along an old road N. 9-50 E. 600 chs.; thence still with said road N. 15 E. 1.24 chs. to a point; thence N. 19 E. 7.95 chs. to a stone 3X; thence N. 61-1/4 E. 3.30 chs. to a stake; thence S. 80-1/4 E. 1.87 chs. to a point in the center of Gilder Creek at an old ford 3X; thence up the meanders of Gilder Creek as the line to the beginning corner.

The above described property is the same conveyed to me, as Trustee, by Leta T. DuPree, et al by deed dated June 30, 1950 and recorded in the R.M.C.
