All that lot of land in Greenville County, State of South Carolina, in Bates Township, being known and designated as lot No. 3 as shown on a plat of property of J. Frank Williams recorded in Plat Book R at Page 63, and being more particularly described according to a recent survey of J.C. Hill, dated December 14, 1950, as follows:
