to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mountain City Milling Co., Inc., its successors and assigns:

ALL that certain lot of land situate in the City of Greenville, County of Greenville, State of South Carolina, in the Fourth Ward of said City and bounded on the East by 'Calvin Street (formerly Boyce Street and also formerly Gas Street) and having, according to a plat made by Dalton and Neves, Engineers, dated May, 1927, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Calvin Street corner of Parker property and running thence with Calvin Street, N. 6-40 E. 159.2 feet to an iron pin on the Southern line of the right of way of the C&WC Railway Co.'s property; thence in a Southwesternly direction with said Southern line of the right of way of the C&WC Railway Co. property 355.3 feet to an iron pin corner of Camperdown Mills property; thence S. 69-55 E. 81 feet to an iron pipe; thence N. 87-30 E. 177.5 feet to an iron pin the beginning corner.
