Know All Men by These Presents:

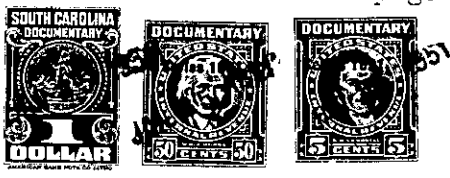
That I, J. E. Watson in the State aforesaid,

Bolt, Trustee for Marguerite Weaver and Virginia Weaver,

All that certain piece, parcel or tract of land situate, lying and being in Butler Township, Greenville County, triangular in shape and containing one acre, more or less, according to plat of the property of Marguerite Weaver and Virginia Weaver made by J. C. Hill January 8, 1951, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on other property of the grantor and running along the line of property of the grantee N. 51-30 E. 505.1 feet to an iron pin, which pin is 39.2 ft. from the Congaree road; thence along the Miller property S. 37 E. 150 feet to an iron pin; thence along other property of the grantor S. 65-50 W. 515.8 feet to an iron pin; thence N. 43-15 W. 20 feet to an iron pin the beginning corner, and being a part of the property conveyed to the grantor herein by W. B. McGowan, Dixon D. Davis and Sara C. McSwain as Executors of the Estate of J. J. McSwain, Dec'd., by deed dated the 15th day of February, 1947 and recorded in the R. M. C. Office for Greenville County in deed volume 307 at page 322.
