All that piece, parcel or lot of land in Paris Hountain Township, Greenville County, state of South C rolina, known as Tract No. 6 on Plat of property of D. B. Tripp, recorded in the R. M. C. Office for Greenville County in Plat Book Y Fage 161 containing 14.57 acres, more or less and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin in road at corner of Tract No. 5 on said plat, and corner of Martin lands, and running thence with Martin line S. 62 . 758 feet to an iron pin in branch; thence with the branch as the line S. 23 E. 518 feet to bend in branch; thence S. 15-30 W. 388 feet to bend in manch; thence S. 45-30 . 370 feet to iron pin; thence leaving the branch N. 68 F. 200 feet to stake; thence with line of Elack N. 39 E. 1749 feet to stake at corner of Lot To. 7; thence with line of lot No. 7 M. 25-30 E. 252 feet to stake in line of lot No. 4; thence with line of lot No. 4 S. 87 E. 80 feet to stake at corner of lot No. 5, and thence with line of lot No. 5 S. 68-15 W. 519 feet to the beginning corner.

The above tract of land was conveyed to Ephraim E. Lorton by  $\mathbb{N}$ . 3. Tripp by deed dated January 15, 1945 recorded in the R. 1. C. Office for Greenville County in Volume 271 page 257 in trust to hold the legal title to said tract of land until his son, Floyd J. Forton, reached the age of 21 years, at which time the logal title was to vest in the said Floyd J. Horton, and the said Floyd J. Lorton is now 21 years of age, and has a legal right to cell the sail tract of land, and his father, Ephraim E. Forton is joining in the execution of said deed individually and as trustee in order that to question may be reject as to this deed parsing a good fee simple title.
