

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the state. James C. Smith

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on the east side of Herbert Street and being known and designated as lot # 40 of a Subdivision known as Elizabeth Heights, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in plat book F at page 298 and also according to a more recent plat of property of James C. Smith prepared by Piedmont Engineering Service IV February, 1951, and according to said plat having the following metes and bounds to-wit:

BEGINNING at an iron pin at the southeast corner of the intersection of Herbert Street and Martin Street and running thence along the south side of Martin Street South 76-15 E 150 feet to an iron pin at joint corners of Lots Numbers 39 and 40; thence along the joint line of said lots, S 13-45 W 60 feet to an iron pin at joint rear corner of lots numbers 40 and 41; thence along the joint line of said lots, N 76-15 W 150 feet to joint corner of said lots on the E side of Herbert Street; thence along the E side of said Herbert Street, N 13-45 E 60 feet to the beginning corner.
