to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert C. Dillard, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the improvements thereon, situate, lying and being on the Southwest side of South Estate Drive, in Gantt Township, near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 29 on plat of Crestwood, Inc., made by J. C. Hill, Surveyor, February 29, 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at page 189, and having, according to said plat and a recent survey made by R. K. Campbell, Surveyor, January 31, 1951, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of South Estate Drive, at joint front corner of Lots 27 and 29, and running thence with the line of Lot 27, S 39-15 W 210.7 feet to an iron pin; thence N 5-45 W 160 feet to an iron pin; thence along the line of Lot 30, N 65-05 E 134.2 feet to an iron pin on the Southwest side of South Estate Drive; thence along the Southwest side of South Estate Drive, S 30-25 E 65 feet to an iron pin, the beginning corner.
