Balentine, Jr., his heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 101, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Bradley Boulevard at the joint front corner of Lot Nos. 100 and 101 and running thence with the joint line of said lots N. 37-34 W. 182.5 feet to joint rear corner of Lot Nos. 100, 101, 113 and 114; thence with the rear line of Lot No. 113 S. 52-26 W. 75 feet to an iron pin joint rear corner of Lot Nos. 101, 102, 112 and 113; thence with the joint line of Lot Nos. 101 and 102 S. 37-34 E. 182.5 feet to an iron pin on the northern side of Bradley Boulevard; thence with said Boulevard N. 52-26 E. 75 feet to the point of beginning.
