all that piece, parcel or lot of land in Oneal Township, Greenville County, State of South Carolina, and also in Beech Springs Township of Spartanburg County, of South Carolina, situate about five (5) miles northeast of the City of Greer, bounded on the north by lands of C. M. Ponder and H. G. Tooley, on the east by lands of J. C. Burnett, on the south by lands of Harriett Ida Tapp and the Estate of G. M.
