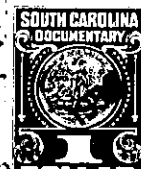

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State

of South Carolina, near the northern corporate limits of Greer, lying on the South side of the U. S. Super Highway No. 29 and on the north side of an unnamed (Earle) Street, and being shown and designated as lot No. 3 on Plat of property of J. C. Moon Estate prepared by H. S. Brockman, Surveyor, June 12th 1947, and being a part of the same property conveyed to J. C. Moon by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 235, at page 207, and having the following courses and distances, to wit:

BEGINNING on a stake on the south edge of the Right of Way of the said Super Highway, joint corner of lots 2 and 3, and runs thence with the dividing line of lots 2 and 3, S. 4-50 W. 52 feet to a stake on the north edge of the unnamed (Earle) street; thence with the North edge of the said unnamed (Earle) Street S. 82-52 E. 93.3 feet to a stake, joint corner of Lots 3 and 4; thence with the dividing line of Lots 3 and 4, N. 4-50 E. 55.5 feet to a stake on the south edge of the rightofway of said Superhighway; thence with the rightof way of said Super Highway, N. 85-00 W. 93.3 feet to the beginning corner.
