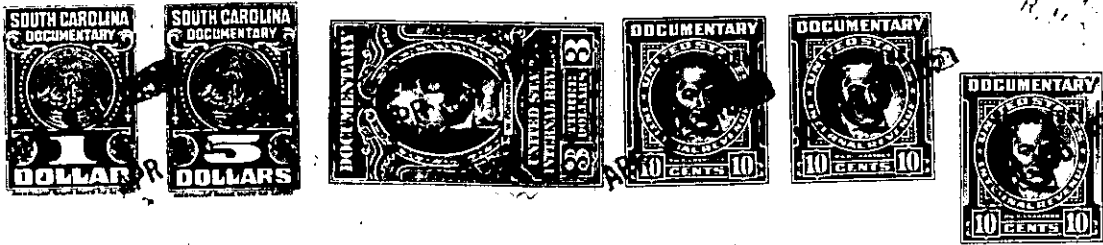

J. F. Welborn and J. F. Welborn, Jr., their heirs and assigns:

all that piece, parcel or lot of land in **Greenville** Township, **Greenville**

County, State of South Carolina, within the corporate limits of the City of
Greenville and being known and designated as Lot Numbers 131 and
132 of a Subdivision known as **Isaqueena Park**, a plat of which is
of record in the R.M.C. Office for Greenville County, in Plat Book
P at Pages 130-131, and having the following metes and bounds, to wit:

BEGINNING at a point at the Northwestern intersection of Kirkwood
Lane with Oxford Street and running thence with the Southwestern
side of Kirkwood Lane N 45-54 W 96 feet to a point; thence continuing
with the Southwestern side of Kirkwood Lane N 64-27 W 34 feet to
the joint front corner of Lots 132 and 133; thence S 44-15 W 166.7
feet to a point at the joint rear corner of Lots 132 and 133; thence
S 37-31 E 18.4 feet to a point; thence S 50-35 E 83 feet to a point
on the Northwestern side of Oxford Street at the joint rear corner
of Lots 120 and 131; thence with the Northwestern side of Oxford
Street N 39-25 E 8 feet to a point; thence continuing with the
Northwestern side of Oxford Street N 58-53 E 156 feet to a point;
thence with the Northwestern intersection of Kirkwood Lane with
Oxford Street N 6-12 W 18.4 feet to the point of beginning.

the joint rear corner of Lots 171 and 172; thence S 46-18 E 90.1
