All that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, containing seventeen and sixty-eight one hundredths (17.68) acres, and described by metes and bounds, according to a plat of the property of E. J. Jaskwhich, as made in January, 1951, by Dalton & Neves, Engineers, reference to which plat is hereby expressly made, as follows, to-wit:
