

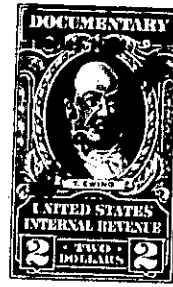
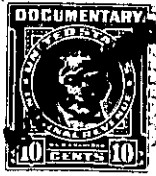

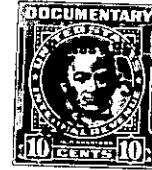

All that piece, parcel or lot of land in Greenville Township, Greenville County, State

of South Carolina, known as Lot No. 72 on plat of lands of H. B. Bates, made by R. E. Dalton, Engr. and recorded in R. M. C. Office for Greenville County in Plat Book "F", page 32, and having the following courses and distances, according to said plat:

BEGINNING at a stake on the northeast side of Bishop Street 300 feet east of Cobb Street, corner of Lot No. 73, and running thence with Bishop Street S. 55-40 E. 75 feet to a stake, corner of Lot No. 71; thence with line of said Lot, N. 48-30 E. 123 feet to stake in line of Judson Mills property; thence with line of said Judson Mills property, N. 54-06 W. 74.5 feet to stake, corner of Lot No. 73; thence with line of said lot, S. 48-30 W. 125.1 feet to the beginning corner; being the same property conveyed to me by Dovie Mason by her deed dated Aug. 1, 1936, and recorded in Vol. 183, at page 48, said R. M. C. Office, to Roma Mason.

ALSO, all that other lot of land in Greenville Township, Greenville County, State of South Carolina, known as Lot No. 73 on said Plat of lands of H. B. Bates by R. E. Dalton, Engineer, and recorded in said Plat Book "F", at page 32. Said lot adjoins the above and has a frontage of 75 feet on the north side of Bishop Street, with a depth on one side of 125.1 feet and on the other side of 127.2 feet; and the rear line being 74.5 feet; being the same property conveyed to Roma Mason by J. A. Lunsford by his deed dated December 7, 1932, and recorded in Vol. 171, at page 14, said R. M. C. Office.

ALSO, all that other lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville and being known and designated as Lot No. 74 on said Plat of lands of H. B. Bates by R. E. Dalton, Engineer, recorded in said Plat Book "F", at page 32, adjoining the above described lot and being the same property conveyed to Roma Mason by J. A. Lunsford by his deed dated Aug. 23, 1933, and recorded in Vol. 115 at page 533, said R. M. C. Office.
