

J. McKinney, his heirs and assigns, foreever:

All that certain piece, parcel or lot of land situate, lying and being on the East side of Claremore Avenue, in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 22, of Block "I", Section 5, on plat of East Highlands Estates, made by Dalton & Neves, Engineers, February 1941, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "K", at pages 78, 79 and 80, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Claremore Avenue, at joint front corner of Lots 21 and 22, and running thence with the line of Lot 21, N 82-47 E 169.8 feet to an iron pin on the Western edge of a 10-foot strip of land reserved for utilities; thence with the Western edge of said strip of land reserved for utilities, N 7-23 W 76 feet to an iron pin; thence with the line of Lot 23, S 82-47 W 170.7 feet to an iron pin on the East side of Claremore Avenue; thence with the East side of Claremore Avenue, S 7-56 E 76 feet to the beginning corner.

This property is conveyed subject to the following building re-

strictions:

1. The lot herein conveyed shall be used for residential purposes only;

No residence shall be erected on said lot costing less than \$7000.00;

3. The building line as shown on the recorded plat and also other restrictions shown on said plat are to be strictly adhered to.

The Granton is to pay 1951 taxes but no assessments for street improvements.
