D. Turner and B. B. Waters and their heirs and assigns forever:

All that certain parcel or lot of land containing 95/100 of an acre, more or less, situated about three miles south from Gowansville, in Highland Township, Greenville County, State of South Carolina, designated as Lot "C" on the amended plat of the property of A. D. Turner and B. B. Waters, by H. S. Brockman, Surveyor, dated March 28, 1951, and having the following courses and distances, to wit: BEGINNING at a stake, corner of Lot "D", and running thence along the Barton line, N. 89.35 E. 498 feet to stake on branch; thence along said branch, S. 55.00 W. 288 feet to stake; thence N. 58.00 W. 308 feet to the beginning corner.
