All that certain piece, parcel or lot of land situate, lying and being on the Northeast side of East Faris Road in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 79 on Plat of Forest Heights made by Dalton & Neves, Engineers, recorded in the R. M. C. for Greenville County, S. C., in Plat Book P, at page 71 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the Northeast side of East Faris Road, joint front corner of Lots 79 and 80, running thence along the joint line of said lots, N. 48-0 E. 179.3 feet to an iron pin on a 20-foot alley; thence with said 20-foot alley, S. 47-44 E. 61.6 feet to an iron pin at the joint rear corner of Lots 78 and 79; thence along the joint line of said lots, S. 43-27 E. 192.5 feet to an iron pin on East Faris Road; thence with East Faris Road, N. 41-38 W. 80 feet to the point of beginning.
