Combractor agrees to the following specifications footing 4" X 12 " concrete foundation Brick floor joint. 2 x 8 dressed 16 " O.C. stude 2 x 4 dressed 16" O.C. Gealing joint 2 x 6 dressed 16 " O.-Q. Rafters 2 x 6 dressed 16" O. C. sub floor 1 " Boards dressed, Floor - Oak Endor I.R.B.R.D R. & hall Pine in kitchen and Bath. Exterior walls Storm sheeting Bex sutside cornice, Interior walls Rock Lath,

The contractor agrees to complete said house by July 6th 1951.

The contractor is to be payed within 60 days after house is completed.

if not payed within 60 days intrest will be payed at rate of 5% on what is due him, the contractor.
