All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina lying and being on the Northeast corner of the intersection of Glennwood Lane and Ridgeway Drive and being known and designated as Lot #61 of Woodfields, as shown on plat thereof, recorded in Plat Book S, Page 7, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Ridgeway Drive joint front corner Lots 61 and 62, and running thence along Ridgeway Drive S. 44-09 W. 80 feet to an iron pin; thence a curveed line N. 74-14 E. 25 feet to an iron pin on Glennwood Lane; thence along Glennwood Lane N. 75-42 W. 80 feet to an iron pin joint front corner Lots 60 and 61; thence along the line of Lot 60 N. 14-18 E. 162.7 feet to an iron pin in the line of Lot 62; thence along the line of Lot 62, S. 45-51 E. 162.9 feet to the beginning corner.
