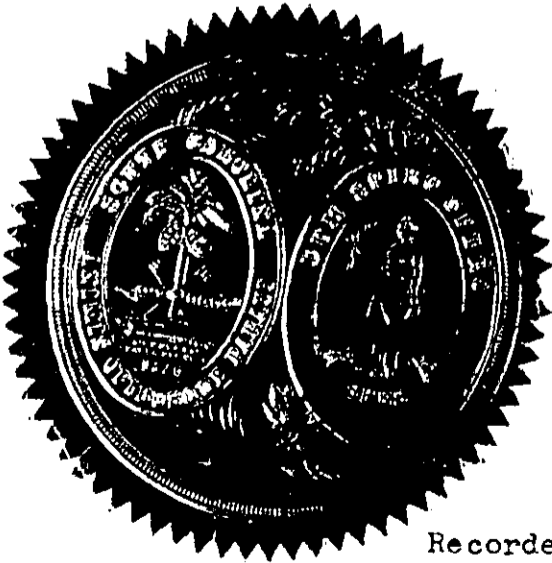
HAVE CERTIFIED, over their signatures, Resolutions authorizing in behalf of the aforesaid
