All that certain parcel or lot of land situated on the northwest side of the Rutherford Road near Jubilee Church, about four miles north from Taylors, in Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 4 of the D. M. Greer Estate, according to survey and plat by H. S. Brockman, Surveyor, dated November 20, 1950, and having the following courses and distances, to wit:
