to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

C. C. Smith, his heirs and assigns, all our right, title, interest and estate in and to all that piece, parcel or lot of land situate, lying and being at Traveler's Rest, County and State aforesaid, being known and designated as Lot No. 5 of the Smith property, and according to plat made by J. C. Hill, L. S., July, 1951, recorded in Plat Book AA, page 119, having the following metes and bounds, to-wit:

BEGINNING at a point on the north side of West Road, which point is 630 feet southwest from the intersection of Geer Highway No. 276 and West Road, at rear corner of Lot No. 4, and running thence along rear lines of Lots Nos. 4, 3, 2 and 1 N. 29 W.; 486.8 feet, the same being rear corner of Lot No. 1; thence S. 71-30 W. 289.6 feet; thence S. 24 E. 510.8 feet to West Road; thence along West Road 323.2 feet to the point of beginning, and being a portion of the property conveyed to Susie E. Smith by E. Inman, Master, by deed dated March 1, 1916, recorded in Deed Book 40 at page 123, the said Susie E. Smith having died intestate on June 5, 1951, leaving as her sole heirs at law and distributees the grantors and grantee herein.
