BEGINNING At a point in line of property of Alfred F. Burgess at the rear corner of Lot No. 32 as shown on said plat of Aberdeen Highlands, which point is S. 42-20 E. 233.2 feet from the Southeast side of Melville Avenue, and running thence along the line of property of grantee S. 42-20 E. 20 feet to a point in the rear corner of Lot No. 42; thence along the rear line of Lot No. 42 S. 47-45 W. 1 foot, more or less, to a poi t in the rear line of Lot No. 42 at the end of a 20-foot alley; thence N. 42-20. 20 feet along the end of said alley to a point in the rear line of Lot No. : thence along the rear line of Lot No. 32 N. 47-45 E. 1 foot, more or less, to the beginning corner.
