All that piece, parcel and lot of land in the City of Greenville, County of Greenville, State of South Carolina, located on the northeastern side of Augusta Road and having according to plat of property of Jamile Francis, Ellison Webster and J. T. Shaleuly, dated November, 1951, by L. P. Slattery, plat to be recorded, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Augusta Road at corner of property being conveyed on this date to Webster, which point is approximately 295 feet from the intersection of Augusta Road and Cureton Street, and running thence along Augusta Road, S. 55-56 E. 40.5 feet to an iron pin at corner of property of Wadlaw; thence along said Wadlaw line, N. 53-42 E. 186.8 feet to iron pin at corner of a 15 foot private alley; thence along the southern side of private alley, N. 55-46 W. 55.6 feet to iron pin at corner of property of Webster; Thence along the line of Webster property, S. 49-04 W. 182.4 feet to iron pin at point of beginning.

This conveyance is made subject to right of way of the South Carolina Highway Department and building restriction lines as shown on the above mentioned plat.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

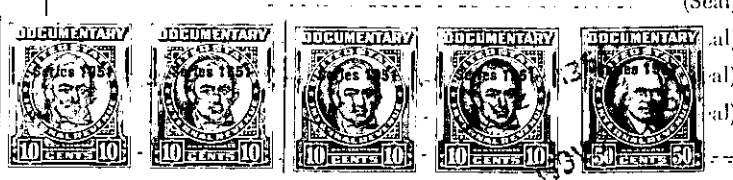
