RIGHT OF WAY AGREEMENT

	Know all men by these presents that for and in consideration of the sum of \$0ne hundred Eighty-eight & 00 (\$188.00), paid to Nellie K. Hopkins

1 8 5 1 i	(hereinafter designated grantor), the receipt of which is hereby acknowledged, the grantor hereby bargains, sells and conveys unto Piedmont Natural Gas Company, Incorporated, a New York corporation (hereinafter designated grantee), and its successors and assignees, a right-of-way and easement for the purposes of laying, constructing, maintaining, operating, repairing, replacing and removing pipe lines (with valves, regulators, meters, fittings, appliances, tie-overs, and appurtenant facilities) for the transportation of gas, oil, petroleum products, or any other liquids, gases, or substances which can be transported through a pipe line, the Grantee to have the right to select the route (the laying of the first pipe line to constitute the selection of the route by the Grantee), under, upon, over, through and across the lands of Grantor, or in which the Grantor has an interest situate in

W gi	There is included in this grant the right from time to time to lay, construct, maintain, operate, alter, repair, remove, change he size of, and replace at any time or from time to time one or more additional lines of pipe and appurtenances thereto including without limitation corrosion control equipment; provided, however, that for each additional line laid after the first line is laid the rantee shall pay the grantor or his heirs or assignees \$1.00 per lineal rod of additional pipe line laid under, upon, over or thru the foredescribed land, or such proportionate part thereof as the grantor's interest in said land bears to the entire ownership thereof.
he oi ui	The grantee shall have all other rights and benefits necessary or convenient for the full enjoyment or use of the rights erein granted, including without limitation the free and full right of ingress and egress over and across said lands and other lands if the grantor to and from the area specifically covered by this grant of easement, and the right from time to time to cut all trees, ndergrowth and other obstructions that may injure, endanger or interfere with the construction, operation, maintenance and reair of said pipe lines; and the grantee shall have the right to assign this grant in whole or in part.
he	To have and to hold said right-of-way and easement unto said grantee, its successors and assignees, until such first pipe line be constructed and so long thereafter as a pipe line is maintained upon said land, and the undersigned hereby bind themselves, their cirs, executors, administrators, successors and assignees to warrant and forever defend all and singular said premises unto the rantee, its successors and assignees, against the claims of all persons whomsoever.
pı ar	The grantee hereby agrees to bury all pipes to a sufficient depth so as not to interfere with cultivation of the soil, and agrees p pay such damages as may arise to growing crops, timber, or fences from the construction, maintenance and operation of said ipe lines; such damage, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one to be popointed by the undersigned, here—successors, heirs or assignees, one by the grantee, its successors or assignees, and the third y the two persons aforesaid, and the award of such three persons, or any two of them, shall be final and conclusive.
w	The grantor may fully use and enjoy said land and premises, except for the purposes granted to the grantee and provided ne grantor shall not construct nor permit to be constructed any house, structures or obstructions on or over, or that will interfere ith the construction, maintenance or operation of, any pipe line or appurtenances constructed hereunder, and will not change the rade over such pipe line.
