to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James W. Starkey, his heirs and assigns, forever:

All that lot of land situate on the East side of Courtney Circle, East of the Old Buncombe Road, near the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 26 on plat of Casa Loma Estates made by Piedmont Engineering Service, October 1947, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book S, at page 65, and having according to said plat the following metes and bounds, to-wit:
