

All that piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, known and designated as lot No. 38 and the eastern half of lot No. 39 as shown on plat of the Perry property in section known as Sans Souci recorded in the R. L. C. Office for Greenville County in plat book 0 at page 45 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin at the southwest corner of the intersection of Blue Ridge Drive and Newland Avenue, and running thence with the west side of Newland Avenue S. 5-50 E. 130 feet to an iron pin corner of lot No. 49; thence with the line of said lot S. 87-45 W. 92.5 feet to an iron pin in the center of the rear line of lot No. 39; thence with the center of said lot No. 5-50 W. 130 feet to an iron pin on the south side of Blue Ridge brive; thence with the south side of said Blue Ridge Drive E. 87-37 E. 92.5 feet to the beginning corner.

This being the same property conveyed to the grantor by two separate deeds of Hext L. Perry as Trustee, one dated July 9, 1945 recorded in volume 278 page 8 and the other dated March 28, 1952 recently recorded.
