

ALSO, all my right, title and interest in and to all those certain lots or parcels of land in Greenville Township in the section known as Nicholtown and being duly shown and described on Plat recorded in Plat Book C, page 235, R.M.C. Office for Greenville County, S.C., as property of the Grantor and E. E. Stone, said lots being designated on said Plat as Lots Nos. 1, 2, 4, 6, 8, 10, 12, 14, 16, 21, 28 and 30. ALSO, all my right, title and interest in and to those certain lots or parcels of land situate on the West side of Fall Street and the South side of Cauble Street in the City of Greenville and being more particularly described as follows:
