All that certain piece, parcel or small plot of land located in Chick Springs Township, School District 9-B, situate at the intersection of "Old Road Bed" and Reid School Road, all as will more fully appear in a plat thereof made by C. C. Jones, dated April 24, 1952, and having according to said plat the following metes and bounds, to-wit:
