All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being on the Eastern side of Dunham Bridge Road and being known and designated as Lot No. 7 of property of Thomas Clifton Collins as shown on a Plat thereof by W.
