Rollinson in the State aforesaid, in consideration of the sum of One Thousand, Three Hundred, Eighty-two and eighty- DOLLARS, & the assumption of a mortgage balance of \$6617.13, held seven cents (\$1382.87) by the Metropolitan Life Insurance Company to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hershel George, his heirs and assigns, All that piece of property in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot no. 110, in a subdivision known as Super Highway Sites, a plat of which is recorded in the R.M.C. Office for Greenville County, in Plat Book P, page 53 and according to a more recent survey by J. L. Hunter, Registered Surveyor, entitled property of Waver M. BEGINNING, at an iron pin on the eastern side of Broad Vista Boulevard at the joint front corner of Lots Nos. 109 and 110, which iron pin is at a point 705.1 feet from the interesection of Broad Vista Boulevard and Bob White Lane, and running thence along the eastern side of Broad Vista Boulevard N. 20 E. 80 feet to an iron pin; joint front corner of Lots 110 and 111; then along the common line of said last mentioned Lots S. 88-0 E. 182.5 feet to an iron pin in the center of a five foot strip reserved for utilities; thence along the center of said five foot strip, S. 2-0 W. 80 feet to an iron pin, the joint rear corner of Lots 109 and 110; thence along the common line of Lots 109 and 110, N. 88-0 W. 182.5 feet to the beginning corner.
