
Know All Men by These Presents:

Andrew W. Ramey and Ollie B. Ramey

All that piece, parcel and lot of land lying and being in O'Neal Township,

Greenville County, South Carolina, and being on waters of Beaverdam Creek and of South Tyger River and being known as a portion of the B. F. Few homeplace and being the lands of the late Merida Waldrop. It begins at a stone in road and runs thence N. 70 1/2 E. 19.45 to a stone; thence N. 26 E. 17.00 to corner; thence N. 17 1/2 E. 1.52 to a stone; thence N. 31 E. 2.66 to stake; thence with creek to corner and N. 50 W. 11,70; thence S. 6 E. 14.50 to a stone; thence N. 70 1/2 E. 4.95 to a stone; thence S. 19 1/2 E. 3.50 to the beginning corner and containing 50 acres, more or less.

This is the same land conveyed to Merida Waldrop by B. F. Few by deed dated November 6, 1897, recorded in Deed Book DDD, Page 20. The said Merida Waldrop who was the father of Jessie W. Poole died intestate several years ago leaving as his sole heir at law the said Jessie W. Poole, his daughter. She by inheritance became the sole owner of the said tract of land. Prior to his death the said Merida Waldrop by his deed dated January 2, 1932 conveyed the said tract of land unto this granter under the name of Jessie Ella Waldrop which deed is not yet recorded but is this day being recorded.
