All that lot of land situate on the southwest side of Beechwood Avenue, in the City of Greenville, in Greenville County, State of South Carolina, shown as Lot 7 on plat of the Davis property, made by R. K. Campbell, and J. L. Hunter, Surveyors, July 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "AA", Page 123, and having, according to said plat, the following metes and bounds, to-wit:

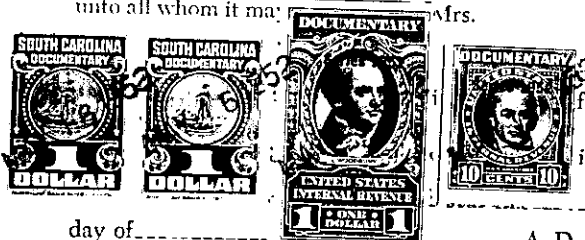
