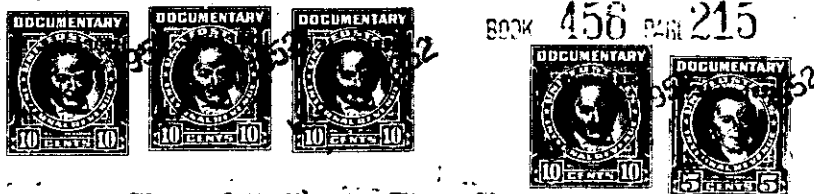


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY



Know All Men by These Presents:

That I, W. Rudolph Shives in the State aforesaid, in consideration of the sum of Four Thousand, Two Hundred Fifty (\$4,250.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s); (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. Otto White, Jr.,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, situate on the Southeast side of Spartanburg Street, and being a portion of the property known as "Joyland" as shown on plat thereof made by R. E. Dalton, Engineer, in July 1939 and recorded in the R. M. C. Office for Greenville County in Plat Book J, at page 102, said lot of land having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Spartanburg Street at the corner of property now or formerly belonging to H. E. Batson, and running thence along the line of the Batson property South 47-30 East eighty-eight and four-tenths (88.4) feet to an iron pin at the rear corner of the Batson lot; thence along the line of property now or formerly belonging to P. R. Long, South 39-20 West thirty-two and seven-tenths (32.7) feet to an iron pin; thence along the line of property now or formerly belonging to P. R. Long, North 57-32 West seventy-two and six tenths (72.6) feet to an iron pin on the Southeast side of Spartanburg Street; thence along the Southeast side of Spartanburg Street, North 20 East forty-nine (49) feet, more or less, to the place of beginning.

This is the same property conveyed to W. Rudolph Shives by deed of W. W. Burgess dated January 26, 1952, and recorded in Deed Book 450 at page 136.

Grantee agrees to pay 1952 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

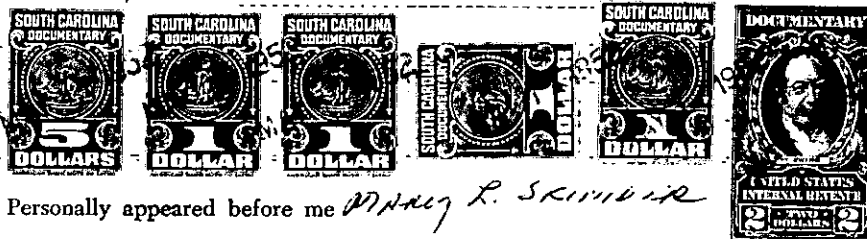
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
