

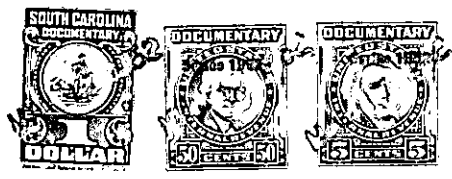

edged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said  
Jonah E. Cox and Lydia J. Cox and their heirs and assigns forever:

All that certain parcel or lot of land situated on the North side of  
Hammond Street in the City of Greer, Chick Springs Township, Greenville  
County, State of South Carolina, designated as Lot No. 10 of the Property  
of G.B. and A.B. Johnson according to survey and plat by J.H. Atkins,  
Surveyor, dated March 25-27, 1946, recorded in Plat Book Q, page 17, R.M.C.  
Office for Greenville County, and having the following courses and
