Batson and her Heirs and Assigns forever,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on Dykeson Street between Franklin Road and Darlington Avenue; in the Ethel Y. Perry Sub-Division situate in the Sans Souci section of Greenville County about three miles north of the City of Greenville, said lot having the following lines, courses and distances:

BEGINNING at an iron pin on the northern edge of a 5 foot sidewalk running along Dykeson Avenue, joint front corner of lots Nos. 25 and 26; thence along the northern edge of said sidewalk, N. 78-30 W., 54.2 feet to an iron pin, joint front corner of Lots 24 and 25; thence along the eastern line of Lot No. 24, N. 14-11 E. 133.15 feet to an iron pin, joint rear corner of Lots Nos. 24 and 25; thence along the rear line of Lot No. 23 S. 80-03 E., 42.2 feet to an iron pin, joint rear corner of Lots Nos. 25 and 26; thence along the western line of Lot 26 S. 9-08 W. 134.2 feet to an iron pin, the beginning corner, said lot being known and designated as Lot No. 25 on Plat of said property recorded in the Office of the Register of Mesne Conveyance for said County and State in Plat Book "R" at Page 127, which plat is hereby referred to and made a part hereof, said lot being shown on the County Block Book as 169-10-19, and conveyed to the grantor herein by Hext M.
