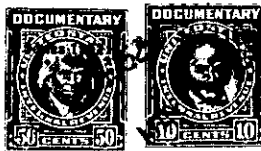

Know All Men by These Presents:

That Carl B. Holland in the State aforesaid, in consideration of the sum of Fifty-Eight Hundred and no/100 (\$5,800.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ralph H. Mann, his heirs and assigns:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southwesterly side of Crosby Circle, near the City of Greenville, S. C., being shown as Lot No. 4 on the plat of Paramount Park as recorded in the R.E. Office for Greenville County, S. C. in Plat Book "W", page 57, and having according to said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the Southwesterly side of Crosby Circle at a point 224.7 feet Northwest of the Southwesterly intersection of Crosby Circle and Dorr Drive, said pin being the joint front corner of Lots Nos. 3 and 4, and running thence along the joint line of said Lots S 55-01 W 156.1 feet to an iron pin; thence N 50-30 W 90 feet to an iron pin; thence N. 40-00 E 100 feet to an iron pin, joint corner of Lots Nos. 4 and 5; thence along the joint line of Lots Nos. 4 and 5 N 89-14 E 113 feet to an iron pin on the Southwesterly side of Crosby Circle; thence along the Southwesterly side of Crosby Circle on a curve, the chord of which is S 23-25 E 50 feet to the point of beginning.

This is part of the property conveyed to the grantor as shown by deed recorded in Deed Book 452, page 256.

This property is conveyed subject to the mortgage given by the grantor to A. W. Agnew in the amount of \$3,000.00, dated February 29, 1952, and recorded in Mortgage Book 524, page 100.
