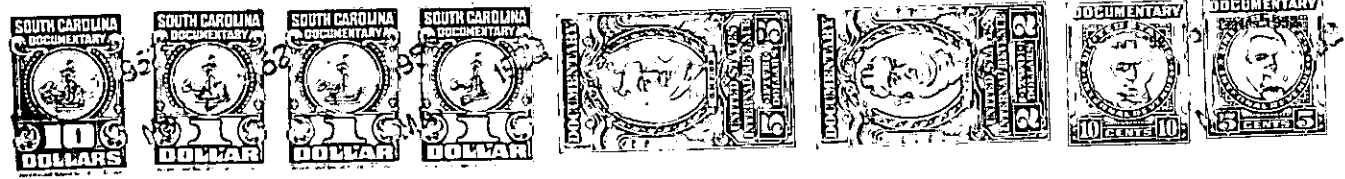
Willis P. Trotter, his heirs and assigns, forever.

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, known and designated as Lot 19, Block H, of the subdivision known as Fair Heights, according to plat of said subdivision recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book F, Page 257, and having, according to said plat, the following metes and bounds, to-wit:
