Know All Men by These Presents:

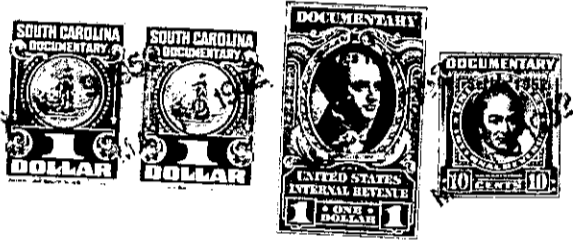
That I, C. O. Berry in consideration of the sum of Eight Hundred (800.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. F. Burrell, his heirs and assigns,

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, about four miles fwest from the city of Greenville, known as the C. O. Berry property (sub-division) made by H. S. Brockman, R. S., May 10-11, 1950. Recorded in R. J. C. office in Plat Book "X" Page 193, and having the following metes and bounds, to-wit:

BEGINNING on the South side of Lily Street at the corner of E. F. Burrell's line S 9-35 E, 259.1 feet to a stake in the branch to Carleton's line; thence with line N 68-40 E, 130.5 feet along said line N 58-15 E, 98.7 feet to the corner of Lot Number Three (3); thence N 27-50 W, 246.5 to the corner of Lily Street, thence South West 165 feet to the beginning corner.
