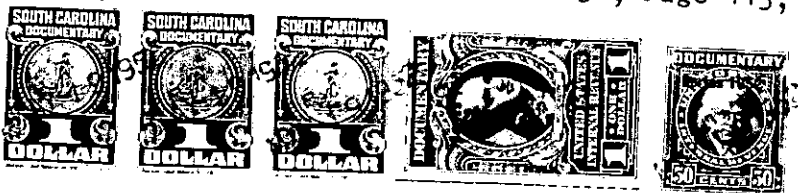

M. C. Office for Greenville County, S. C. in Plat Book "Z", Page 1, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Mayfair Lane at joint front corner of Lots 28 and 29, and running thence with the line of Lot 28, N. 87-07 E. 222.8 feet to an iron pin; thence along the rear line of Lot 40, S. 5-01 W. 84.5 feet to an iron pin; thence with the line of Lot 30, S. 88-07 W. 212.8 feet to an iron pin on the East side of Mayfair Lane; thence along the East side of Mayfair Lane, N. 1-53 W. 80 feet to the beginning corner.
