to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ward S. Stone and his heirs and assigns, All that certain piece parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina shown on a plat of property of E. Godfrey Webster said plat being drawn by "J. Middle, surveyor, and is dated 12 May 1952. Said lot of land has, according to the above mentioned plat, the following courses and distances to wit:

Beginning at a point on the eastern side of Green Ave., said point being N.29-00". 84 feet from the inside edge of the sidewalks on the north east corner of Green Avenue and Ansel (formerly St. John) streets and running from said point N.29-00E. 57 feet along Green Avenue; thence S. 70-41E. 149.2 feet; thence S. 27-15W. 65.3 feet; thence N. 78-41W. 74.2 feet; thence N. 64-09W. 76 feet to the beginning point on Green Ave.

This being the same lot of land conveyed to E. Godfrey Webster by deed of E. Inman, master, dated 5 Dec. 1935 and is recorded in the office of the A.M.C. for Greenville county S.C. in deed book 183 page 26.
