Know All Men by These Presents:

That I, F. Lucy Elletson in consideration of the sum of Fifteen Hundred (\$1500.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Herman H. Campbell,

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, on the south side of East North Street (formerly known as Old Spartanburg Road) being known and designated as an eastern portion of lot No. 53 as shown on plat of property of Overbrook Land Company recorded in plat book F page 252 and having according to a more recent survey made by J. C. Hill, May 16, 1952 the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of East North Street, the joint corner of lot Nos. 53 & 54 and running thence with the joint line of said lots S. 7-41 E. 205 feet to an iron pin on the north side of a 10 foot alley; thence with the north side of said alley S. 76-07 W. 60 feet to an iron pin corner of other property of the grantor; thence with the line of said property N. 7-41 W. 205 feet to an iron pin on the south side of East North Street; thence with the south side of said street N. 76-07 E. 60 feet to the beginning corner.

This is a portion of the property conveyed to the grantor by two separate deeds, one by C. H. Yates dated January 27, 1926 recorded in deed volume 106 page 379 and the other by S. C. National Bank of Charleston and Marion M. Hewell as executors and trustees under will of Charles H. Yates dated October 2, 1944 recorded in deed volume 268 page 99.

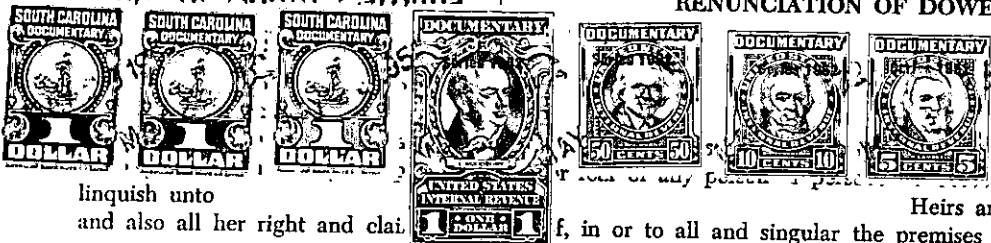
