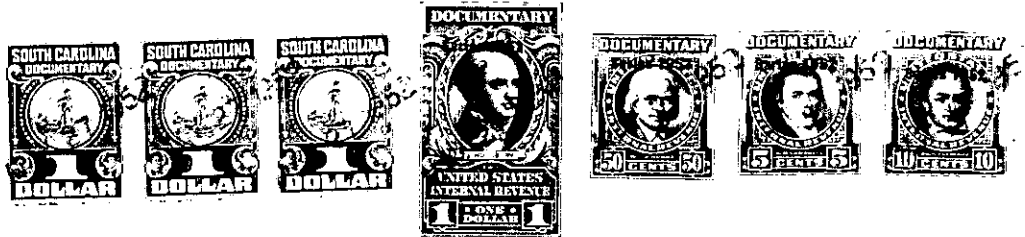

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and being known and designated as Lot #7 of the Ollie C. Dill, Henry P. Dill, Jr. and Mollie C. Dill Property, located on the North Franklin Road about four and one-half (4-1/2) miles North of Greenville, plat of said property being recorded in Plat Book B at page 135 in the R. M. C. Office for Greenville County, S. C. and having the following metes and bounds, according to said plat, as follows:-
