

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert L. McPherson, his heirs and assigns, forever.

All that piece, parcel or lot of land on the southwest side of South Carolina Highway No. 291, in the City of Greenville, Greenville County, State of South Carolina, snown as Lot No. 21 on plat of Holmes Acres, made by Dalton & Neves, Engineers, February 1951, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "Z", Page 1, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of South Carolina Highway No. 291 at joint front corner of Lots 21 and 22 and running thence along the line of Lot 22, S. 49-48 W. 165 feet to an iron pin; thence N. 30-44 W. 79.2 feet to an iron pin on the southeast side of Mayfair Lane; thence with the curve of Mayfair Lane (the chord being N. 31-55 E. 38.9 feet) to an iron pin; thence still with the southeast side of Mayfair Lane, N. 49-48 E. 114.9 feet to an iron pin at the corner of Mayfair Lane and South Carolina Highway No. 291; thence with the southwest side of said highway, S. 40-12 E. 90 feet to the beginning corner.
