Know All Men by These Presents:

That I, J. T. Massey in consideration of the sum of -----Nine Hundred and No/100 ----- in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said GEORGE W. THOMPSON AND CHRISTINE THOMPSON, their heirs and assigns forever,

ALL that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, being known and designated as Lot No. 3 as shown on plat of property of J. T. Massey made by W. J. Riddle, Surveyor, May 1948 and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint front corner of Lots 4 and 3 on Proposed Street and running thence along said Proposed Street North 32-35 East 100 feet at joint corner of Lots 3 and 2; running thence along the joint line of Lots 3, 2 and 1 South 27-25 East 200 feet to an iron pin; running thence South 62-35 West 100 feet to an iron pin at the rear joint corner of Lots 4 and 3; running thence along the joint line of said lots, North 27-25 West 200 feet to an iron pin, the beginning corner.

This lot is sold subject to the following restrictions:

- 1. No house shall be erected thereon costing less than \$7,000.00
2. This property shall not be sold, rented or otherwise disposed of to negroes or persons of African descent.
3. No outside closets or toilets shall be erected on said premises.
4. This property shall be used for residential purposes only.
5. No building shall be erected nearer than 5 feet to any side line; nor any house closer to the Street than the houses which are now located on said Street.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

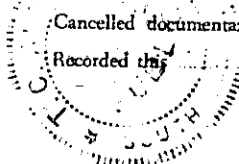
