

All that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, situate, lying and being on Callahan Avenue, Sans Souci Heights, a subdivision situate on the New Buncombe Road about four (4) miles North of the City of Greenville, South Carolina, being known and designated as Lot No. 100 on Map #3, on plat of said property recorded in the R.
