M. C. Office for Greenville County in Plat Book "S", at page 17 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Primrose Lane, joint front corner of Lots Nos. 67 and 68 and running thence along the line of Lot No. 67, N. 9-15 W. 200 feet to the joint rear corner of Lots Nos. 67 and 68; thence N. 80-45 E. 90 feet to an iron pin, joint rear corner of Lots Nos. 68 and 69; thence along the line of Lot No. 69, S. 9-15 E. 200 feet to an iron pin on the north side of Primrose Lane; thence with said Lane, S. 80-45 W. 90 feet to the point of beginning, being a portion of the property conveyed to the grantors herein by deed of W. A. Bates dated January 22, 1932, which deed is recorded in the R. M. C. Office for Greenville County in Deed Book 162, page 78. The above described property is subject to restrictive covenants of record in the R. M. C. 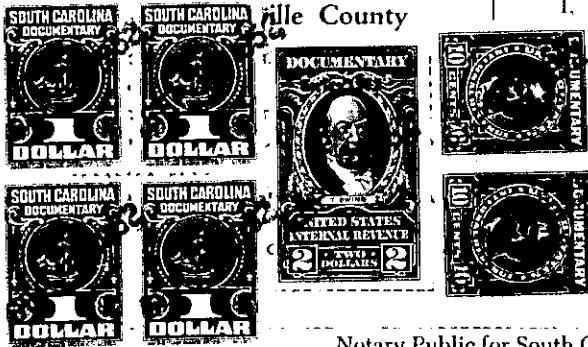
